**WHEREAS**, said General Tax Roll have been examined by said City Council and found to be in correct order;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MATHS, TEXAS;**


**Section 1:** That the Adjusted Taxable Value of the City of Mathis for the year 2018 is \$111,356,293.

**Section 2:** That the Mayor of said City be and is hereby authorized to execute a Certificate of Approval and Acceptance of said Certified Tax Roll by affixing his signature and seal of the City of Mathis, Texas, thereto.

**Section 3:** This ordinance shall take effect and shall be in full force and effect from and after its passage.
